Terms of Program

Program: A description of the Cool Air Rebate program can be found at <http://shops.coolairrebate.org/> (the "Program").

Payment for Diagnostic Fees: Participating Repair Shop is entitled to 100% payment of diagnostic fees from CAR if repairs qualify under Program terms; 90% payment of diagnostic fees from CAR if repairs do not qualify under Program terms or if vehicle owner refuses to do the repair.

Qualifying Repair: The Program only applies to diagnosis and repair of leaking MVAC systems using R-134a refrigerant performed at CAR Program approved facilities. ("Qualifying Repair"). CAR will not cover work performed prior to the consumer's approval of their application and letter of eligibility (LOE) or after it has expired. Financial assistance is based on the availability of funds.

Payment for Qualifying Repair: Participating Repair Shop is entitled to payment from CAR of 90% of cost of Qualifying Repair up to a maximum amount of \$1,500.00 per vehicle. The consumer is responsible to pay 10% of the cost of Qualifying Repair and the full amount of any charge over \$1,500.00.

Right to refuse repair: Consumer is entitled to refuse to repair the vehicle at any point up to the start of the repair.

Disputes: Participating Repair Shop is responsible for adjudicating and resolving disputes directly with the consumer. CAR is not responsible for, nor will CAR participate in, dispute resolution with Participating Repair Shop customers.

Release of Liability: Participating Repair Shop hereby assumes all risk of injury or harm as a result of participating in the Program and agree to release, indemnify, defend, and forever discharge CAR from all liability, claims, demands, damages, costs, expenses, and causes of action due to death, injury, loss, or damage to the Participating Repair Shop. Participating Repair Shop designee acknowledges that I have read and understand this agreement, and I understand that I cannot pursue any of the claims and rights that I have waived in this agreement at any time in the future.
